1 **[PROPOSED] FINAL JUDGMENT**

2 This matter came before the Court on February 16, 2023, regarding the unopposed *Motion for*  
3 *Final Approval of Class Action Settlement* (the “Motion”) on the terms set forth in the *Amended*  
4 *Settlement Agreement and Release of Class Action* (the “Settlement”). In conformity with California  
5 Rules of Court, rule 3.769, the Final Approval Order, and the Settlement, **THE COURT HEREBY**  
6 **ENTERS FINAL JUDGMENT AS FOLLOWS:**

7 1. All terms used in this order shall have the same meanings given as those terms are used  
8 and/or defined in the parties’ Settlement and the Motion.

9 2. The Settlement Class is defined as: *All individuals who worked for one or more of the*  
10 *Defendants as an independent contractor in California during the period from September 1, 2020,*  
11 *through January 31, 2021.*

12 3. Only one Class Member—Lev Smagin—elected to exclude themselves from the  
13 Settlement. That individual will not be bound by the Settlement and will not receive any portion of the  
14 class-allocation of the Net Settlement Amount.

15 4. Defendants Praesidium Diagnostics LLC, Sameday Health, and Felix Huettenbach  
16 (collectively, “Defendants”) shall fund the settlement in the Revised Gross Settlement Amount of  
17 \$417,000.00 in accordance with the terms of the Settlement and the allocations set forth in the Final  
18 Approval Order.

19 5. The Settlement Administrator, ILYM Group, Inc., shall distribute the funds in  
20 accordance with the Settlement and this Court’s Order Granting Motion for Final Approval of Class  
21 Action Settlement, issued on February 17, 2023.

22 6. All uncashed check will be remitted pursuant to Code of Civil Procedure section 384 to  
23 the California State Controller for deposit in the Unclaimed Property Fund in the name of the individual  
24 whose check was uncashed.

25 7. The Court retains continuing jurisdiction over the Action and the Settlement, including  
26 jurisdiction pursuant to rule 3.769(h) of the California Rules of Court, solely for purposes of  
27 **(a)** enforcing the Settlement Agreement, **(b)** addressing settlement administration matters, and  
28 **(c)** addressing such post-judgment matters as may be appropriate under court rules or applicable law.
